



How many CPD credits can I claim? 2022-2023

This is a list of a range of educational and professional activities that attract CPD credits. Activities listed are classified into three categories:

C – Clinical A – Academic P – Professional

The list is not exclusive. The log is designed to allow recording of learning related to personal development in the range of clinical, laboratory and professional settings in which Pathologists work and learn.

It is the responsibility of appraisers to check, at each annual appraisal, that the distribution of CPD activity corresponds appropriately to the scope of work of the person being appraised. Simply accumulating numerous CPD credits that relate to one small part of your practice is not sufficient.

For allocation of CPD credits for published works it is NOT intended that every author of a multi-author work should claim the maximum number of CPD credits set out below. Rather, each author should reflect on the work undertaken and the learning gained and claim an appropriate share of the CPD credits. The reasonableness of that decision should be subject to review by the appraiser.

* The Royal College of Pathologists recognises CPD credits awarded by other medical royal colleges.
